- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution had submitted affidavit dated 14.03.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 05.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, the SRC in its  $388^{th}$  meeting held on  $14^{th}-15^{th}$  September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution on 24.02.2022. The institution has submitted reply on 14.04.2022.
- 4. AND WHEREAS, the SRC in its 410<sup>th</sup> meeting held on 25<sup>th</sup> & 26<sup>th</sup> April 2022 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee on perusal of the reply submitted by the institution, decided that the continuation order be issued to the institution Maharani College of Education, Survey No 50/1 & 48/3, Nanjiyapalayam Village, Dharapuram, Tirupur Main Road, Nanjiyampalayam, Dharapuram Taluk, Erode District, Tamilnadu-638657 for B.Ed. programme for 2 basic units of 50 students each."
